Introduction

This is the Workforce Demographic report based on data available as at 30 June 2018.

Under the Health Practitioners Competence Assurance Act 2003 (HPCAA):

- all practising pharmacists are required to hold an annual practising certificate (APC) regardless of the number of hours they practise each year, and;
- the Pharmacy Council is required to maintain a register of pharmacists.

The data is collected as part of our obligations under the HPCAA and is also used to monitor and report on the demographic and geographic spread of pharmacists across New Zealand. It enables us to make annual comparisons and monitor workforce trends.

To help in developing the sector each year, the collected data is made available in an annual report - referred to as the *Workforce Demographic Report*. This report is prepared for the year ending 30 June 2018. However the <u>public register</u>, available through our website has live data.

The key findings from the collected data is structured under four key themes:

- 1. Pharmacist registration nationally
- 2. Pharmacist workforce by region
- 3. Pharmacist workforce demographics
- 4. Pharmacist work type

The supporting data for all the findings are detailed in the attached appendices.

1. Pharmacist Registrations Nationally

As at 30 June 2018, across New Zealand, the key highlights in terms of registration were:

3,787 practising pharmacists

1,095 non-practising pharmacists

259 new pharmacists registered


24 pharmacist prescribers (19 practising)

236 intern pharmacists registered

7.89 practising pharmacists per 10,000 population

3,787 practising pharmacists

2018 has seen an increase of 1.8 percent in practising pharmacists since 2017, a rise of 69 pharmacists across the country. The average annual increase for the previous three years is 2.6% (Range 1.8% - 3.9%).



1,095 non-practising pharmacists

The number of non-practising pharmacists as at 30 June 2018 was 1,095; 140 out of 1,095 pharmacists have not renewed their registration status.

7.89 practising pharmacists per 10,000 population

Based on the number of practising pharmacists (3,787) and the Stats NZ 30 June 2017 population estimation, the ratio of practising pharmacists per 10,000 is 7.89.




Council processed 259 new registrations in the year ending 30 June 2018. Of these registrations:

- 23 pharmacists were from countries regarded as having similar pharmacy practice standards as New Zealand, whether this was by registration of a legislative arrangement (TTMRA³ for Australia) or because they held recognised equivalent qualifications (Canada, Ireland, UK and USA)
- 236 were transfers from the intern pharmacists scope of practice; new Zealand and Australian graudates and 2 overseas pharmacists (Non-REQR ⁴route)



236 intern pharmacists

Intern numbers are similar to last year. 53% of students graduated from Otago university. Overseas pharmacists registering in the intern scope remains at a steady 3%.



As at 30 June 2018, 76% of pharmacists work in only five regions with the highest being Auckland (37.3%)


The following graph shows the distribution of pharmacists within each region:



Demographic profile of the pharmacy workforce

West Coast

As demonstrated on the heat map of New Zealand, throughout the regions, there is considerable variation in the indicative workforce density. This could be further exacerbated given the lower population density in rural regions. (Regional estimated population data for 30 June 2017).



As at 30 June 2018, 2,481 (65.5%) practising pharmacists are female and 1,306 (34.5%) are male.


The number of female pharmacists continues to increase particularly within the younger age bracket (i.e. 20's and 30's)

Ethnicity of practising pharmacists

While NZ European/Pākehā remain the dominant ethnic group (50 percent) amongst registered pharmacists, Asians represent the fastest growing ethnic group (26 percent (+2%)) on the register. Māori and Pacific Island groups are not well represented.




