# **First Aid Policy**



# **Relevance to Health Practitioners Competence Assurance Act 2003**

1. Section 118 – Standards of Competence

## **Policy Statement**

2. At the point of registration in the pharmacist scope of practise all pharmacists must hold a First Aid Certificate in NZQA Unit Standards:

6400 Manage first aid in an emergency situation

6401 Provide first aid

**6402** Provide basic life support

3. Pharmacists must maintain a level of first aid competence commensurate with their role and professional obligations.

#### Rationale

- 3. All pharmacists are required to hold a current First Aid Certificate for entry to the profession as part of the registration process.
- 4. Pharmacists practising in a primary care, patient facing setting, in the community must be able to rend assistance in an emergency.
- 5. It is a pharmacist's ethical<sup>1</sup> and professional duty<sup>2</sup> to provide emergency first aid where necessary, in line with professional role and expertise.
- 6. Pharmacists practising in a secondary care (hospital) setting may elect to maintain a level of competence in first aid as deemed appropriate by their employer and as reflected by their professional obligations. In the hospital setting, highly skilled medical personnel are able to administer emergency care promptly therefore it is unlikely that hospital pharmacists will be required to administer first aid. Hospital policies often preclude pharmacists from administering life saving measures.

## **Implementation**

### Entry to the profession

- 7. Intern pharmacists are required to provide their preceptor with a full, current first aid certificate for their final EVOLVE appraisal and complete a self-declaration on the Society Learning Management System (LMS) confirming their certificate will be valid when lodging the application for registration in the Pharmacist scope of practice.
- 8. Overseas pharmacists applying for registration through the Recognised Equivalent Qualifications Route (REQR) are not required to hold a current certificate at the time of full NZ registration. Instead, they are expected to hold a current certificate by the next APC renewal date if they work in direct patient care (including primary care) as part of their practice.

 Overseas pharmacists seeking registration via the Non-Recognised Equivalence Route (NON-REQR) will need to hold a full current first aid certificate at the time of NZ registration in the pharmacist scope of practice.

## **Maintenance of competence**

- 10. Pharmacists practising in primary care (Community Pharmacy, General Practice or consulting with patients in a primary care setting) must, as a minimum, maintain competence in providing emergency first aid through completion of a refresher course in CPR equivalent to New Zealand Resuscitation Council (NZRC) Level 2 or NZQA Unit Standard 6402, once every THREE years. This should be recorded as part of a continuing professional development process.
- 11. Pharmacists who provide a vaccination service must comply with requirements set by the Immunisation Advisory Centre (IMAC). These are outlined in the IMAC booklet on the Ministry of Health website. Since the requirements include cardiopulmonary resuscitation (CPR) training, pharmacist vaccinators do not need to do an additional Level 2 CPR course every three years.
- 12. Individual pharmacists may choose to maintain competence at a level higher than the Council requires. The decision should be based on self-reflection and assessment of their own and their community's requirements. For example, a pharmacist practising next to a medical centre may only need CPR, whereas a pharmacist in a remote or rural setting may want to maintain their medical emergency training at a higher level, for example New Zealand Resuscitation Council CORE Advanced.
- 13. Pharmacists who are designated workplace first aid providers must comply with WorkSafe New Zealand requirements regarding first aid competency.
